# **Academic Integrity in the Admissions Process**

Whether you're writing your admissions composition or taking the online exam, it's important to use your own ideas and answers. Working independently and truthfully reflects your commitment to learning and growth. By applying academic integrity in everything you do, you demonstrate respect for your own achievements and for the efforts of others. Upholding these values throughout the process ensures fairness and builds trust in your abilities.

# **Academic Integrity for the Student Composition**

As IB learners, being principled means doing what is right, even when no one is watching. This includes being honest in your work, using your own ideas, and giving credit to others when you use their words or thoughts. When writing your admissions essay, it's important to apply this by using your own words and original ideas. This shows respect for your learning and the work of others. Being principled helps us build trust and ensures that we are always learning and growing in the right way.

**GRADE 6** students who are <u>eligible for access to English education</u> and who wish to be considered for admission into the International Baccalaureate Programme must write an entrance exam on:

# Sunday, May 11<sup>th</sup>, 2025 (8:00am – 12:00pm)

This exam will be conducted entirely <u>ONLINE</u>. Candidates must have access to their own desktop or laptop computers to write this exam—tablets and phones are not compatible with the platform.

The following steps must be completed in order to register your student for the exam:

- 1. Read through all sections of this package before completing your student's registration.
- Complete the online Registration Form with BrissonLegris and submit your payment (\$60.94 taxes included):

- c. A scanned copy of your student's IEP if the student is entitled to special accommodations

#### Please Note:

Families of students who require special accommodations must contact Ms. C. Moriello for specific instructions prior to the registration deadline (<a href="mailto:cmoriello@nfsb.qc.ca">cmoriello@nfsb.qc.ca</a>). The time of your exam on May 11, 2025 may be different to allow for accommodations.

REGISTRATION PERIOD: April 1st (8:00 am) to May 1st (11:00 pm)

All required documents and your payment must be received **before** the May 1<sup>st</sup> (12:00 pm) deadline for your student to be registered.

Documents and payment cannot be hand-delivered.

The International Baccalaureate Programme at Howard S. Billings provides a high quality of education in a public setting. We offer an enriched curriculum, extra-curricular activities, leadership opportunities, cultural exchanges, and international trips. Students are educated in a secure and supportive environment where they are free to grow in body, mind, and spirit; they will become well-rounded individuals.

We are currently accepting applications for the 2025-2026 school year at the MYP 1 (grade seven) level. The entrance exam will take place on Sunday, May 11<sup>th</sup>, 2025. **The exam will be completed entirely online**. There will be a fee of \$60.94 (taxes included) to write this exam. This fee covers the cost of the standardized testing done by BrissonLegris, a company with more than 35 years of experience in evaluation. This fee must be paid online at the time of registration.

Howard S. Billings is a recognized world school for the International Baccalaureate Programme covering grades 7 to 11. The IB Programme is recognized around the world. The curriculum and pedagogy of the IB Programme focus on international perspectives of learning and teaching, while insisting that students fully explore their home cultures and languages. IB teachers participate in a wide variety of professional development opportunities to constantly update their knowledge and share their expertise with colleagues around the world. We must receive all required elements of the registration package to register your student with BrissonLegris; incomplete registrations will result in a nullification of your student's registration.

#### INFORMATION FOR PARENTS

#### PREPARING FOR THE ONLINE SECONDARY SCHOOL ADMISSIONS EXAM

Your child will soon be taking their Secondary 1 (grade 7) admissions exam. The exam will be completed online in the comforts of your home and will be supervised virtually by the BrissonLegris team. Parents can prepare in advance by ensuring that they have the right equipment and a suitable environment for the test.

This document contains information about:

- Computer equipment and environment needed for taking the online exam
- Review process and next steps
- Special accommodations for students
- Consent and authorization to take the online exam

Any child who has finished Grade 5 is ready to write the exams. However, if you think it is necessary, you can review the material covered in English, Math and French in Grade 5.

Entrance exams also test logical deduction, reasoning, observation and reading skills. No studying is necessary for these aspects.

#### **COMPUTER REQUIREMENTS**

#### **Technical requirements**

- Minimum environment required for your computer: An operating system capable of supporting the latest version of your web browser is required. If you are able to navigate the demo platform, your system is adequate.
- Recommended Internet browser: Chrome (best), Microsoft Edge, Safari, Firefox, Mozilla.
   Important! Don't use Internet Explorer.

Make sure your browser language is set to English. When you visit a website, your browser should not translate the content into other languages.

- Microphone and webcam in good working condition.
- Speakers or headphones with microphone.
- A mouse.



WARNING! Tablets, iPads, Chromebooks, and mobile phones are not compatible because they won't allow you to use the exam platform and Zoom (for remote supervision) at the same time. You must have a computer. Please use only a personal computer. The restrictive settings of a professional computer (government or business computer) prohibit the opening of the test platform.

#### Internet connection

- Reliable, high-speed internet connection.
- On the day of the exam, the other members of your household should refrain from using the interneton their computers, telephones or televisions (e.g., Netflix) to avoid connection problems.



**IMPORTANT!** 

Using the microwave during the exam session could also interfere with your Wi-Fi and disconnect you from the exam platform. Be sure to let your family know!



TIP:

Check your internet speed in advance. Make sure you have a high-speed connection to avoid losing the connection.

#### **Exam environment**

- Set up your child in a **calm and quiet area**, where they can be left **alone**. Remember to close the windows and turn off all telephones, alarms, and other devices in the house! We recommend a room with door that closes, if possible.
- Ensure your child is visible in the camera. Your child must be visible throughout the entire exam period.
- You may not use virtual wallpaper. You may not use two screens.
- You may not use calculators, cell phones, the internet, or other means of communication.
- Do not make any noise during the exam, as the microphone will be turned on!
- The virtual supervision will be recorded for monitoring purposes.



#### PROCESS AND NEXT STEPS

#### **Invitation email from BrissonLegris**

- Approximately, three (3) to four (4) days before the day of the exam, you'll receive an invitation email from BrissonLegris. It will specify the exact time of your child's exam and include a personalized link toconnect to the Zoom platform.
- Simply click the Zoom link on the day of the exam and a BrissonLegris invigilator will authorize you to access the virtual classroom. You don't need to subscribe to Zoom. The application will download automatically the first time you use it. The link to the exam platform will be provided by the coach when you'll be in the Zoom session. Remember to familiarize your child with the exam platform(demo). The link is presented on the first page of this document.
- The invitation email will also contain the support team's email address, in case you have trouble loggingin (Zoom).
   Please note that the support team will only respond to emails on the day of the exam.
   IMPORTANT! If you still haven't received the invitation email 48 hours before the exam, please check all your email inboxes first and then inform the school.
   If you have other questions or must miss the exam, contact the school directly.



#### **IMPORTANT!**

Check your **junk mail or spam folder** for the invitation email. You can also search your inbox for the keyword "Zoom." The email subject line will say: *Invitation –Online exam / BrissonLegris* 

#### The day of the exam

- You should be present with your child when they log in to Zoom. You'll be directed to a virtual classroomwith 16 students. Log in 15 minutes in advance.
- When you click the link to the Zoom meeting, you'll be directed to a virtual waiting room. You may haveto wait a few minutes. Make sure you agree to use video and audio when prompted by Zoom.
- The invigilator will go over the instructions for taking the exam. You'll only need to be present at the beginning of the exam to help your child log in to the platform. At the beginning of the session, the invigilator won't answer any questions about the content of the exam.
- Once you've logged in to the exam platform, parents will be asked to leave the room. The invigilator willexplain the instructions to students and answer their questions before the exam begins. However, it is important for the parents to not leave the house during the exam. If your child has a technical problemthat the invigilator is not able to resolve, you may be needed to resolve the situation.



#### TIP:

We invite you to consult the links presented on the first page of this document in order to familiarize yourself with the platforms.



#### **IMPORTANT!**

The total exam duration is approximately 2 hours (including instructions). <u>Your child</u> <u>won't be able to go off-screen at any time during the exam.</u> Make sure your child has scrap paper, a pencil, a water bottle and their glasses (if applicable). You also need to have **your child's permanent code** in order to log in to the platform.

#### Is your child applying to more than one school that uses BrissonLegris online admissions exams?

There are a few exam options offered by BrissonLegris. The school decides which exam option they will use. Your child can only take the exam **once for each option**. So, if two schools have chosen the same exam option, you will be notified before the second exam and the result will be sent automatically to the school. The results will be sentonly to the schools using **the same exam option**.

The school is responsible for the admissions process and final decision. They will contact you with the results. Brisson**Legris** will not share results with families.



#### SPECIAL ACCOMMODATIONS

- Students entitled to special accommodations (with school permission) will be provided with:
  - ✓ 30% more time for each part of the exam
  - ✓ A text read aloud function (that's why it's important to have headphones or a headset)



The text read aloud button is located below each question. The invigilator will provide specific instructions for children who are entitled to special accommodations.

• Therefore, it's important to confirm access to special accommodations with the school in advance. Nochanges can be made once you've received the invitation email or on the day of the exam.

#### CONSENT AND AUTHORIZATION TO TAKE THE ONLINE EXAM

By allowing my child to take the Secondary 1 online admissions exam and by ensuring their presence on the day ofthe exam:

- 1. I hereby accept that Brisson**Legris** administer the exams and supervise the online exam via the Zoom platform. The ratio is one invigilator per 16 students.
- 2. I confirm that I can meet the technological requirements for the exam and that I have read the information provided above and consulted the demo platform to ensure that my child is prepared for the exam.
- 3. I acknowledge that it is my sole responsibility to ensure access to an adequate internet network during the entire exam period. If this is not possible, it is my responsibility to notify the school before the exam.
- 4. I accept that the exam session will be recorded for security and review purposes. The recording will be stored confidentially and may only be used for verification purposes. In the event that plagiarism, copying, exam reproduction or the use of unauthorized materials is suspected, the Advisory Committee (BrissonLegris and the school) will perform averification and the parents of the concerned child will be informed.
- 5. I understand that, on the day of the exam, I must be present on Zoom at the beginning of the scheduled time to make sure my child is set up properly and is clearly visible in front of the camera. I am also aware that the invigilator cannot answer questions about the exam type or processing of the results.
- 6. I agree to follow all instructions provided by the invigilator and to leave my child alone for the duration of the exam. I also agree to respect the privacy rights of all children taking the exam and their parents.
- 7. I agree not to copy, reproduce, photograph, film or record the exam questions or the supervision on Zoom (to protect the privacy of the virtual class members). The publication of exam content, in whole or in part, is strictly prohibited during and after the exam period.
- 8. I agree to inform my child that they may not use the internet, a calculator, cell phone or other means of communication during the test.
- 9. Under Law 25 of the protection of personal data, Brisson Legris undertakes to use and provide the necessary information only to the following people:
  - o To BrissonLegris employees responsible for payment tracking and registering for assessments.
  - To the various stakeholders (accompanying persons, supervisors) during the online assessment.
  - o To the schools chosen during registration for the transmission of results.
- 10. I understand and hereby authorize Brisson**Legris** to send the test results to the school(s) that my child is applying to this year
- 11. I understand that the school has sole discretion on whether or not to admit my child to its regular or specific program. The school will contact me with their decision. BrissonLegris will not provide any results to parents.

If I am not comfortable with the exam terms and conditions, I understand that I must inform the school and, if necessary, cancel my child's exam session.
